## **Test Site**

The Water Test is a private home on the west side of Cayuga Lake. Parking is available under shade trees next to the house. There is no access to the house but there is a port-o-potty and fresh water is available from an outdoor hose.

## **\*\*\* NCA Dog Aggression Policy \*\*\***

"Any dog that in the opinion of the Event Committee, attacks a person or a dog at an NCA working event, resulting in an injury, and is believed by that Event Committee to present a hazard to persons or other dogs, shall be disqualified. When the dog is disqualified by the Event Committee pursuant to this section, a report shall be filed with the NCA Board. The disqualified dog may not again compete at any NCA working event, nor be on the grounds of an NCA working event unless and until, following application for reinstatement by the owner to the NCA Board, the owner receives official notification in writing from the NCA Board that the dog's eligibility has been reinstated. "

## **Bitches in Season**

Bitches in season will not be allowed on the test site until just prior to being judged, which will be after all other dogs are tested. When not being tested, bitches in season must be contained in a designated area away from the official test areas. If you are entering a bitch, do you anticipate she might be in season? As a courtesy, please inform the Test Secretary prior to the test.

## **Spectators and Non-entered Dogs**

Spectators as well as non-entered dogs (except bitches in season) are welcome at the GRNC Water Test. As a courtesy to our exhibitors, we ask that all dogs be kept quiet and leashed or crated.

## **Safety Observances**

Dogs must be crated or on leash at all times.

When on leash, the length of the leash must not exceed SIX feet and may NOT be a retractable leash.

When on leash dogs must be under control at all times.

Dogs showing uncontrolled or aggressive behavior will be asked by the event chair, a board member, safety officer or other official to leave the site promptly or be crated for the duration of the test.

## Directions

**East/West on I-90 NY State Thruway**—Take the RT 414 S **Exit 41** toward US 5-20 Waterloo/Seneca Falls . In .8 miles merge onto NY 414 / Ridge Rd. In .3 miles turn left on NY 318. In 4.2 miles turn slight left onto US 5/20. Then turn right onto Rte 89. In approximately 23 miles turn left on Deerlick Springs Rd . In .7 miles turn left onto County Rd 153. The test site is in .3 miles.

**South from Ithaca**—take Rte 89 North. In approximately 20 miles, Turn right on Derrlick Springs Rd. In .7 miles turn left onto County Rd 153. The test site is in .3 miles
